
- The exercise price of the Stock Options is ₹ 633.55 per option.

- The options granted under VGL ESOP (As Amended)- 2006 will vest as per the following table:

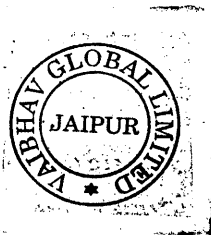
Year	% of Options Granted
